Overview

The ATAC Rotation Fund is managed by Toroso Investments, LLC, an independent registered investment advisor. The strategies were developed by Portfolio Manager Michael A. Gayed, CFA.

The Funds rotate offensively or defensively based on historically proven leading indicators of volatility, with the goal of taking less risk at the right time.

Investment Process

- 1 Analyze. Do conditions favor higher or lower stock market.
- 2 Rotate. Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities with Leverage.
- 3 Evaluate. Weekly for potential changes.

Commentary

The lumber/gold signal experienced a fair amount of volatility in the 4th quarter, which prevented it from delivering any consistent messaging. Lumber prices saw some sharp swings as investors tried to price in weaker credit conditions, sluggish manufacturing and a more hawkish Fed. As a result, performance for the quarter landed right between the risk-on and risk-off assets, lagging growth & small-cap stocks, but outperforming long-term Treasuries. Of some benefit was the fact that the rotation strategy managed to reduce some overall risk and made risk-adjusted performance look a little better.

While we were disheartened by the fund's overall performance during the quarter, we understand that volatile price swings in either lumber or gold can make it more challenging to get an accurate read on short-term conditions. We were encouraged, however, to see stocks & bonds returning to their traditionally inverse correlation. With several potential risk catalysts ahead in 2025 - a new president, geopolitical risks, inflation risk, etc. - the correct expression of risk-off behavior will be important to the success of our risk rotation strategies. If the markets begin pricing in the credit risk we see as a market vulnerability, the fund is positioned to potentially respond to such opportunities.

Leveraged ETF Risk. Leveraged ETFs seek to provide investment results that match a multiple of the performance of an underlying index (e.g., three times the performance) for a single day and rely to some degree, often extensively, on derivatives to achieve their objectives.
